The account is considered past due after thirty (30) days if not paid in full. A late fee of \$25 may be assessed each month the account is past due. As a result of being past due, all voting privileges and participation in GCC activities are terminated until the account is paid in full or with special permission granted by the Board of Directors with advice from the General Manager.

For accounts 60 days past due- restriction of charges to member account (no charging privileges)

For accounts 90 days past due- termination of membership privileges and forfeiture of stock in accordance with article V, section 1 of the Georgetown Country Club By-laws. This rule is applicable to all members (active & Past)

Georgetown Country Club Stockholder Membership Information

This is a 12-month contract. You will be billed on a monthly cycle, all payments (dues, capital improvement funds, assessments, etc.) will be charged with credit card on file around the 10th of every month. Within the first 12 months of membership there will be a \$500 fee to cancel said membership (\$300 cancellation fee for Jr. Executive, \$100 cancellation fee for Social). This membership will roll over to month to month payments starting the month following your one-year anniversary. At that time, a 30-day written notice will need to be given to cancel the membership without penalty.

Stock Information

A share of stock in the Georgetown Country Club shall be valued at \$150.00; a refund of \$100.00 will be made on a surrendered share when it is resold by the club.

Food and Beverage Minimum

A food & beverage minimum charge of \$75 per quarter will also be applied to all membership categories. Each membership will be required to spend at least \$75 per quarter on food and/or beverages. All sales are recorded by member number. Upon quarterly calculation, each membership will be billed for any amount below the \$75 usage minimum plus sales tax.

Monthly Billing
